

CONTRACT ADVANTAGE™ WEB SYSTEM REQUIREMENTS

All requirements apply to client-hosted applications. If you are purchasing Contract Advantage as a service, only the Workstation Requirements apply.

SERVER REQUIREMENTS

The Web Server, Application Server and Database Server may all exist on the SAME server. This is entirely up to the client and should adhere to corporate server configuration policies.

Hard Disk	100GB+ minimum free RAID 1 or RAID 5 recommended Local or SAN Storage for docs	Storage requirements greatly depend on the volume and types of documents attached to the contract records, which are stored in a managed folder structure.
Processor Speed	2GHz or higher recommended	The faster, the better (2 GHz server, or faster, will provide the best performance).
